1 Prices

1.1 Master's Degree in Business Administration and Management

240 euros/credit.

1.2 Master's Degree in Marketing Technologies

220 euros/credit.

1.3 Master's Degree in Technological Talent Management

202 euros/credit.

1.4 Master's Degree in Financial Innovation and Fintech

205 euros/credit.

1.5 Master's Degree in Technology and Innovation Communication

221 euros/credit.

2 Scholarships and grants

This section details the scholarships and grants for the total amount of the enrolment fee available in the 2025-2026 academic year. It should be noted that the following scholarships and grants are in no case cumulative. They are only compatible with the **5% discount for choosing the "single payment" as a method of payment for the enrolment fee.**

2.1 Scholarships for the academic excellence of university graduates

• 10% discount: university graduates or equivalent with an academic record mark of more than 9 out of 10 in previous university studies taken in Catalonia.

Documents to be submitted for acceptance of the scholarship: academic transcript of the bachelor's degree previously studied in Catalonia.

2.2 UPC Alumni scholarships

■ 15% discount: university graduates from the Universitat Politècnica de Catalunya*.

Documents to be submitted for the acceptance of the scholarship: title of the bachelor's degree taken at the UPC or the receipt of the title in process.

*This discount is subject to availability and will be granted to a limited number of students.

2.3 Euncet Alumni scholarships

• 40% discount: Euncet Business School university graduates.



Documents to be submitted for the acceptance of the scholarship: title of the bachelor's degree taken at Euncet or the receipt of the title in process.

2.4 International scholarship

15% discount: students from Africa, Central America, South America and India.
Documents to be submitted for the acceptance of the scholarship: passport.

2.5 Family aid

• 9% discount: students with one or more siblings enrolled in the same academic year of a Euncet Business School bachelor's or master's degree.

Documents to be submitted for the acceptance of the grant: enrolment of the enrolled student.

2.6 Aid for Eurofitness and UFEC employees

 25% discount: student with an employment contract with one of these institutions at the time of enrolment.

Documents to be submitted for the acceptance of the grant: header of the last payslip, employment contract or certificate from the company itself.

2.7 Aid for Euncet employees

• 60% discount: student with an employment contract at EUNCET FORMACIÓN S.L. at the time of enrolment.

Documents to be submitted for the acceptance of the aid: header of the last payslip, employment contract or certificate from the company itself.

In certain cases, the commercial department may grant aid not explicitly contemplated in this document and approved by the school's management.

3 Admission

To formalise admission to a master's degree, the student must make a payment of **€2,000** as a booking fee.

The advance payment of admission implies a commitment by the student to start studies. No total or partial refund of this amount will be made, unless the student does not meet the access requirements.

Once the enrolment has been formalised, the economic regime established by Euncet Business School will apply. The total price of the enrolment fee will be deducted from the amount advanced for admission.



4 Tuition payment methods

4.1 Single payment

This payment option will be made **no later than 5 working days** after the enrolment has been formalised.

4.2 Payment in instalments

Students can split the enrolment fee (except for the reservation) in a maximum of 7 instalments without any interest or commission under prior acceptance by Euncet Business School.

5 Effects of not paying tuition

Failure to pay the enrolment fee or some of the instalments within the established deadlines will result in the temporary suspension of the student's rights.

6 Enrolment modifications

Applications for modification of enrolment will not be accepted.

7 Tuition resignation

As a general rule, **tuition cannot be waived** after 15 days after the completion of the admission process. However, in duly justified cases and only once, students may request the total resignation of enrolment (except for the reservation of a place) by making an instance. The management of the centre will assess the documentation provided and will give the decision within a maximum period of 15 working days.

8 Fees for official academic procedures

- Official bachelor's and master's degree title with European Diploma Supplement (and duplicates): 218.15 euros.
- Issuance of official academic certificates: 27.27 euros.
- Issuance of academic certificates: 30 euros.
- Transfer of academic record: 54.54 euros.
- Studies of academic record for the validation, adaptation, transfer and recognition of study plans: 54.54 euros.
