1 Prices

1.1 Master's Degree in Business Administration and Management

- Price per credit: 234 euros/credit.

1.2 Master's Degree in Marketing Management

- Price per credit: 212 euros/credit (On-Site Part-Time Modality).
- Price per credit: 220 euros/credit (On-Site Modality).

2 Scholarships

2.1 Scholarships for Academic Excellence for university graduates

Discount to be deducted from the total tuition fee for the 2024-2025 course. It is not cumulative.

- 10 %: university graduates or equivalent with an academic record grade higher than 9 out of 10.

2.2 Becas a estudiantes de la UPC

15% a descontar del importe total de la matrícula del curso 2024-2025. No es acumulable.

- Estudiantes que hayan obtenido un título de grado o equivalente en la UPC.

2.3 Becas a estudiantes de Euncet

60% a descontar del importe total de la matrícula del curso 2024-2025. No es acumulable.

- Estudiantes que hayan obtenido un título de grado o equivalente en Euncet Business School.

2.4 Beca Internacional

15% a descontar del importe total de la matrícula del curso 2024-2025. No es acumulable.

- Estudiantes extranjeros procedentes de fuera de la Unión Europea.

3 Aids

3.1 Ayudas familiares

9% to be deducted from the total tuition fee for the 2024-2025 course. It is not cumulative.

- Student with one or more siblings enrolled in the same academic year of a Euncet university degree or master's degree.
- Student with a family income of less than €30,000 gross per year (family unit).

3.2 Professional aids

9% to be deducted from the total tuition fee for the 2024-2025 course. It is not cumulative.

- Student who certifies more than one year as a self-employed worker.
- Student who has been legally unemployed for more than a year.

3.3 UFEC and Eurofitness aids

9% to be deducted from the total tuition fee for the 2024-2025 course. It is not cumulative.

- Student with a membership card from one of the Catalan, Spanish or international sports federations and with a minimum seniority of 3 years.
- People subscribed to any of the sports facilities managed by the Union of Sports Federations of Catalonia (UFEC) and Eurofitness.

3.4 Aids to EUROFITNESS, LEITAT and UFEC employees

25% to be deducted from the total tuition fee for the 2024-2025 course. It is not cumulative.

- Student with an employment contract at one of these institutions at the time of registration.

In certain cases, the commercial department may grant financial **aid not explicitly contemplated** in this document.

It is necessary to bear in mind that these scholarships and aids cannot be accumulated in any case. They are only compatible with the **5% discount for choosing a single payment as the tuition payment method**.

4 Admission

To formalize admission to a master's degree, the student must make a payment of **1.000 euros** as a reservation.

Advance payment of admission implies a commitment from the student to begin their studies. No full or partial refund of this amount will be made, unless the student does not meet the access requirements.

Once registration is formalized, the economic regime established by Euncet Business School will apply. The amount advanced for admission will be deducted from the overall registration price.

5 Payment methods

5.1 Single payment

The bank transfer must be in **Euro currency**. Any bank transaction costs will be borne by the payer.

5.2 Payment in instalments

Students who have obtained a bachelor's degree or equivalent with Euncet Business School or the UPC can split the tuition fee (except the reservation) with a maximum of 10 installments without any interest or commission.

6 Consequences of not paying tuition

Failure to pay the tuition or some of the installments within the established deadlines may result in the temporary suspension of the student's rights in the terms provided in the decree that sets the prices for the provision of academic services in Catalan public universities of the current academic year.

Payment of unpaid instalments of previous courses is required as a prior condition for enrollment or the issuance of degrees or certificates.

7 Enrollment modifications

The Euncet academic calendar provides, for each school period, a deadline to accept requests for modification of registration:

- First quarter:

- **From September 2 to 27, 2024:** registration modification requests are accepted. Those that are resolved favorably have no cost to the student.
- **From September 28, 2024, on,** registration modification requests will **NOT** be accepted.
- Second quarter:
 - Registration modification requests will **NOT** be accepted.

8 Tuition resignation

As a general rule, **registration cannot be waived**. However, in duly justified cases and only once, students may request a total waiver of enrollment and to receive the requested academic services as long as they do so within the period established in the academic calendar, regardless of the date on which registration has been formalized.

In any case, students who renounce registration for the first year will lose their assigned place and, if they wish to re-enroll, they must be admitted again in the pre-registration process or in accordance with the access regulations of those studies.

Euncet's academic calendar has a deadline to accept applications for waiver of registration:

- **Until September 27, 2024:** all requests to waive registration will be evaluated favorably and the entire amount that the student has paid will be returned, except for the admission reservation for new access candidates.
- **From September 28 to October 19, 2024:** all requests to waive registration will be evaluated favorably, but the student must pay a **fee of 1,000 euros**.
- **From October 20, 2024, on,** applications to waive registration will **NOT** be accepted.
- Second quarter:
 - Waive registration requests will **NOT** be accepted.

The **access fee to the content is 80 euros** per subject enrolled at the time of resignation.

9 Fees for official academic procedures

- Official university degree and master's degree with European Supplement on the Title (and duplicates): 218,15 euros
- Issuance of official academic certifications: 27,27 euros
- Issuance of academic certificates: 30 euros
- Transfer of academic record: 54,54 euros
- Academic record studies for validation, adaptation, transfer and recognition of study plans: 54,54 euros
