## 1 Prices

---

### 1.1 Master's Degree in Business Administration and Management

- Price per credit: 240 euros/credit.

### 1.2 Master's Degree in Marketing Technologies

- Price per credit: 220 euros/credit.

### 1.3 Price per credit for the extraordinary exams of the Master's Degree in Marketing Management

- Second retake enrolment: 70 euros/credit.
- From the third retake enrolment: 75 euros/credit.

## 2 Scholarships

---

### 2.1 Academic Excellence Scholarships for university graduates

To be deducted from the total amount of enrolment for the 2024-2025 academic year. Not cumulative.

- 10 %: university graduates or equivalent with an academic record grade higher than 9 out of 10.

### 2.2 Scholarships for UPC students

15 % to be deducted from the total amount of enrolment for the 2024-2025 academic year. Not cumulative.

- Students who have obtained a bachelor's degree or equivalent at the UPC.

### 2.3 Scholarships for Euncet students

60 % to be deducted from the total amount of enrolment for the 2024-2025 academic year. Not cumulative.

- Students who have obtained a bachelor's degree or equivalent at Euncet Business School.

### 2.4 International Scholarship

15 % to be deducted from the total amount of enrolment for the 2024-2025 academic year. Not cumulative.

- Foreign students from outside the European Union.

## 3 Aid

---

### 3.1 Family aid

Aid in the form of a 9% discount on the total enrolment fee for the 2024-2025 academic year. It is not cumulative.

- Student with one or more siblings enrolled in the same academic year of a bachelor's degree or a master's degree from Euncet Business School.
- Student with a family gross income of less than €30,000 (family unit).

### 3.2 Professional aid

Aid in the form of a 9% discount on the total enrolment fee for the 2024-2025 academic year. It is not cumulative.

- Student who certifies more than one year as a self-employed worker.
- Student who has been unemployed for more than one year.

### 3.3 UFEC and Eurofitness aid

Aid in the form of a 9% discount on the total enrolment fee for the 2024-2025 academic year. It is not cumulative.

- Student with a membership card from one of the Catalan, Spanish or international sports federations and with a minimum seniority of 3 years.
- People subscribed to any of the sports facilities managed by the Unió de Federacions Esportives de Catalunya (UFEC) and Eurofitness.

### 3.4 Aid for Eurofitness, LEITAT and UFEC employees

Aid in the form of a 25% discount on the total tuition fee for the 2024-2025 academic year. It is not cumulative.

- Student with an employment contract at one of these institutions at the time of enrolment.

The amount of aid has been established based on an **enrolment of 60 credits of courses to be taken**.

In certain specific cases, the commercial department may grant **aid not explicitly contemplated** in this document.

It is necessary to bear in mind that these scholarships and aids cannot be accumulated in any case. They are only compatible with the **5% discount for choosing a single payment as the tuition payment method**.

## 4 Admission

---

To formalise admission to a master's degree, the student must make a payment **of 1.000 euros as a reservation**.

Advance payment of admission implies a commitment from the student to begin his/her studies. No full or partial refund of this amount will be made unless the student does not meet the access requirements.

Once registration is formalised, the economic regime established by Euncet Business School will apply. The amount advanced for admission will be deducted from the overall registration price.

## 5 Payment methods

---

### 5.1 Single payment

This payment option must be made **no later than 5 business days after registration** has been formalised.

The bank transfer must be in **Euro currency**. Any bank transaction costs will be borne by the payer.

### 5.2 Payment in instalments

Students who have obtained a bachelor's degree or equivalent with Euncet Business School or the UPC can split the tuition fee (except the reservation) with a maximum of 10 instalments without any interest or commission.

## 6 Consequences of not paying enrolment

---

Failure to pay the tuition or some of the instalments within the established deadlines may result in the temporary suspension of the student's rights in the terms provided in the decree that sets the prices for the provision of academic services in Catalan public universities of the current academic year.

Payment of unpaid instalments of previous academic years is required as a prior condition for enrolment or the issuance of degrees or certificates.

## 7 Enrolment modifications

---

The Euncet Business School academic calendar provides, for each school period, a deadline to accept requests for modification of registration:

- First quarter:
  - **From July 2 to October 20, 2024:** enrolment modification requests are accepted. Those that are resolved favourably have no cost to the student.
  - **From October 20, 2024, on,** enrolment modification requests will **NOT** be accepted.
- Second quarter:
  - Enrolment modification requests will **NOT** be accepted.

The academic director of the centre is responsible for resolving enrolment requests submitted.

## 8 Enrolment resignation

---

As a general rule, **enrolment cannot be waived**. However, in duly justified cases and only once, students may request a total resignation of enrolment and to receive the requested academic services as long as they do so within the period established in the academic calendar, regardless of the date on which enrolment has been formalised.

In any case, students who renounce enrolment for the first year will lose their assigned place and, if they wish to re-enrol, they must be admitted again in the pre-registration process or in accordance with the access regulations of those studies.

Euncet Business School's academic calendar has a deadline to accept applications for enrolment resignation:

- First quarter:

- **From July 10 to October 20, 2024:** all enrolment resignation requests will be evaluated favorably and the amount that the student has paid will be returned, except for the reservation of admission for new access candidates.
- **From October 21 to October 31, 2024:** all resignation requests will be evaluated favorably, but the student must pay a fee of 1.000 euros.
- **From November 1, 2024, on:** resignation requests will **NOT** be accepted.
- Second quarter:
  - Resignation requests will **NOT** be accepted.

The academic director of the centre is responsible for resolving resignation requests submitted.
