1.6 Price per recognised credit for all bachelor's degrees

Tuition fee for credits recognised in:

- Previous university studies at Euncet: 2 euros/credit*.
- Previous university studies taken outside Euncet: 5 euros/credit*.
- CFGS: 5 euros/credit^{*}.
- University extension activities: 5 euros/credit*.
- Accredited work and professional experience: 5 euros/credit*.

Scholarships and grants

This section details the scholarships and grants for the total amount of the enrolment fee available in the 2025-2026 academic year. It should be noted that the following scholarships and grants are in no case cumulative. They are only compatible with the **5 % discount for choosing the "single payment" as a method of payment for the enrolment fee.**

The application period for scholarships and grants for new students is from 1 January to 31 October 2025.

The application period for scholarships and grants for students at the centre is from 15 June to 27 July 2025.

Applications will not be accepted outside of these dates.

2.1 Access scholarships

 10 % discount: for new students from Baccalaureate with an access mark equal to or greater than 10 out of 14 or students from CFGS with a mark equal to or greater than 9 out of 10.

Documents to be submitted for the acceptance of the scholarship: proof of university pre-enrolment or certificate of access to university studies from CFGS (mark with 3 decimal places).

2.2 Scholarships for academic performance

• 18 % discount: for the student with the best academic performance (RA) of each university degree.

Documents to be submitted for the acceptance of the scholarship: certificate granted by the academic direction.

Calculation of academic performance (RA):

■ RA =∑QF / NA

Where

2

- ∑QF = sum of the final grades of the subjects enrolled during the 2023-2024 academic year.
- NA = number of subjects enrolled.
- Recognised and validated subjects are excluded from this calculation.

The conditions for awarding this scholarship are as follows:

- RA \geq 80 points out of 100.
- NA ≥ 6.

2.3 Scholarships for honours

Students with honours in the previous academic year (in subjects taken at Euncet) have an exemption from the current year's tuition fee of 25 % of the amount of the number of credits obtained with this academic qualification. It is cumulative.



2.4 Family aid

Students who have accessed the bachelor's degree <u>during the 2025-2026 academic year or</u> <u>later.</u>

• 12 % discount: for students with one or more siblings enrolled in the same academic year of an Euncet bachelor's or master's degree.

Documents to be submitted for the acceptance of the scholarship: enrolment of the enrolled student.

• 12 % discount: for students with a valid large family or single-parent card*.

Documents to be submitted for the acceptance of the scholarship: valid card at the time of enrolment.

* If you have an expired card, you must provide the renewal document in process during the dates of application for scholarships and grants. It will be left pending approval until the card is obtained.

Students who have accessed the bachelor's degree <u>during the 2024-2025 academic year or</u> <u>earlier.</u>

• 14 % discount: for students with one or more siblings enrolled in the same academic year of an Euncet bachelor's or master's degree.

Documents to be submitted for the acceptance of the scholarship: enrolment of the enrolled student.

• 14 % discount: for students with a valid large family or single-parent card*.

Documents to be submitted for the acceptance of the scholarship: valid card at the time of enrolment.

14 % discount: for students who can prove a family income of less than €30,000 gross per year (family unit) and who have accessed the bachelor's degree during the 2024-2025 academic year or earlier.

Documents to be submitted for the acceptance of the aid:

- Cohabitation registration flyer (where all the people who live in the home are listed).
- Income of each member of the family unit (if you do not make the income, provide the negative certificate from the Treasury)**.
- * If you have an expired card, you must provide the renewal document in process during the dates of application for scholarships and grants. It will be left pending approval until the card is obtained.
- ** In special cases and/or in case of doubt, the Admissions and/or Academic Management Department will request the delivery of additional documentation for the validation of the grant.

2.5 UFEC aid

Students who have accessed the bachelor's degree <u>during the 2025-2026 academic year or</u> <u>later.</u>



• 5 % discount: for students with a card from one of the Catalan federations who have accessed the bachelor's degree during the 2025-2026 academic year or later.

Students who have accessed the bachelor's degree <u>during the 2024-2025 academic year or</u> <u>earlier.</u>

• 9 % discount: for students with a card from one of the Catalan federations who have accessed the bachelor's degree during the 2024-2025 academic year or earlier.

Documents to be submitted for the acceptance of the aid: proof of payment of the last 4 years as a member of the federation.

- Payment for the 2024-25 season.
- Payment for the 2023-24 season.
- Payment for the 2022-23 season.
- Payment for the 2021-22 season.

2.6 Grants for training centres

 18 % discount: for students who have completed the Baccalaureate or a CFGS in a training centre that has a collaboration agreement signed with Euncet. It is only applicable to the registration of the 1st year.



Documents to be submitted for the acceptance of the grant: academic certificate from the institute.

2.7 Aid for Eurofitness and UFEC employees

• 25 % discount: student with an employment contract with one of these institutions at the time of enrolment.

Documents to be submitted for the acceptance of the scholarship: header of the last payslip, employment contract or certificate from the company itself.

2.8 Aid for Euncet employees

• 60 % discount: student with an employment contract at EUNCET FORMACIÓN S.L. at the time of enrolment.

Documents to be submitted for the acceptance of the scholarship: header of the last payslip, employment contract or certificate from the company itself.

In certain cases, the commercial department may grant aid not explicitly contemplated in this document and approved by the school's management.



3 Admission

Admission will be carried out through the myEuncet digital platform, to which the interested person will be referred once he/she applies for access to the bachelor's degree. To formalise admission to a degree, the interested person must make a payment of €600 as an advance on the enrolment fee. No refund, either total or partial, of this amount will be made, except in the event that the candidate does not meet the access requirements. Once the enrolment has been formalised, the economic regime established by Euncet will apply. The total price of the enrolment fee will be deducted from the amount advanced for admission.

This payment does not guarantee in any case access to the bachelor's degree requested, nor to its modality. To access the bachelor's degree, it is necessary to meet the requirements established by the University Access Office of the Generalitat de Catalunya (Accesnet).

4 Tuition payment methods

4.1 Single payment

This payment option has an **additional discount of 5 %** on the amount of the credits enrolled minus scholarships, grants and reservations, provided that the payment is made, at the latest, within **5 working days after the enrolment has been formalised**. Payment must be made through the myEuncet digital platform. The bank transfer must be in **euro currency**. Any bank transaction fees will be borne by the payer.

4.2 Direct debit instalment payment

This payment option has the following features:

- It can be divided into a maximum of 11 instalments (the minimum being 2 and the maximum 11), although the last instalment to be paid, regardless of which month the first instalment begins to be paid, may not be later than June 5, 2026.
- **<u>As a general rule</u>**, all instalments will be of the same amount.
- The receipts are issued on the **5th of each month** from the date of enrolment and can be paid by direct debit at any financial institution.
- This modality has no interest or commissions.
- In the event of a return of the direct debit bill, a surcharge of **30 euros will be charged for management fees**.

5 Effects of not paying tuition

Failure to pay the enrolment fee or some of the instalments within the established deadlines will result in the temporary suspension of the student's rights.



Payment of outstanding amounts for enrolments from previous years is required as a precondition for enrolment, issuance of titles or certificates.

6 Enrolment modifications

The academic calendar of Euncet provides, for each academic period, a deadline for admitting requests for modification of enrolment:

- First semester:
 - **Until 26 September 2025**: applications for enrolment modification are accepted.
 - **From 27 September 2025**: applications for enrolment modification will **NOT** be accepted.
- Second semester:
 - **From 7 January to 6 February 2026**: applications for extension and/or modification of enrolment will be accepted. This modification may not, in any case, reduce the total number of credits enrolled.
 - **From 7 February 2026**: applications for enrolment modification will **NOT** be accepted.

7 Tuition resignation

As a general rule, **you cannot waive your enrolment**. However, in duly justified cases and only once, students may request the total resignation of enrolment and to receive the requested academic services as long as they do so within the period established in the academic calendar, regardless of the date on which the enrolment has been formalised.

In any case, students who renounce their first-year enrolment will lose the assigned place and, if they wish to re-enrol, they must be readmitted in the pre-enrolment process or in accordance with the access rules in force for those studies.

The Euncet academic calendar provides a deadline for admitting applications for resignation of enrolment:

- Until September 26, 2025: in duly justified cases and for a single time, students may request the resignation of enrolment (except for the payment and deposit as an advance, in the case of new students) by making an application. The management of the centre will assess the documentation provided and will give the decision within a maximum period of 15 working days.
- From 27 September 2025: applications for resignation of enrolment will NOT be accepted with the exception of the reallocation of places for new students. They must make an application attaching the supporting documentation. The management of the centre will assess the documentation provided and will give the decision within a maximum period of 15 working days.

8 Fees for official academic procedures

• Official bachelor's and master's degree title with European Diploma Supplement (and duplicates): 218.15 euros.



- Issuance of official academic certificates: 27.27 euros.
- Issuance of academic certificates: 30 euros.
- Transfer of academic record: 54.54 euros.
- Studies of academic record for the validation, adaptation, transfer and recognition of study plans: 54.54 euros.
