1 Prices

1.1 Business, Innovation and Technology (Business Tech); Marketing, Innovation and Technology (MKT Tech).

Price per credit in the 1st Year subjects:

 - Second time enrolling: 132 euros/credit*.
 - Third time enrolling: 154 euros/credit^{*}.
- <u>On-Site Part-Time Modality</u>:
 - First time enrolling: 110 euros/credit*.
 - Second time enrolling: 123 euros/credit*.
 - Third time enrolling: 144 euros/credit*.

1.4 Price per recognized credit for all degrees

Tuition price for credits recognized in:

Previous university studies completed at Euncet: 2 euros/credit*.



- Previous university studies completed outside of Euncet: 5 euros/credit*.
- Ciclos Formativos de Grado Superior (CFGS): 5 euros/credit*.
- University Extension Activities: 5 euros/credit*.
- Accredited work and professional experience: 5 euros/credit^{*}.

2 Scholarships and aids

2.1 Access Scholarships

18% to be deducted from the total tuition fee for the 2024-2025 course. It is not cumulative.

- For new students from high school with an access grade equal to or greater than 10 out of 14.
- For new students coming from a CFGS with a grade equal to or greater than 9 out of 10.

2.2 Scholarships for academic performance

18% to be deducted from the total tuition fee for the 2024-2025 course. It is not cumulative.

- For the student with the best academic performance (RA) in the 2023-2024 academic year of the degree in Business Administration and Management (BBA).
- For the student with the best academic performance (RA) in the 2023-2024 academic year of the degree in Marketing and Digital Communication (MKT).
- For the student with the best academic performance (RA) in the 2023-2024 academic year of the degree in CTEF.
- For the student with the best academic performance (RA) in the 2023-2024 academic year of the double degree in BBA and MKT.

Calculation of academic performance (RA):

■ RA =∑QF / NA

Where,

- ∑QF = sum of the final grades of the subjects enrolled during the 2022-2023 academic year.
- NA = number of subjects enrolled.
- Recognized and validated subjects are excluded from this calculation.

The conditions for granting this scholarship are:

- RA \geq 80 points out of 100.
- NA ≥ 6.



2.3 Scholarships for academic distinctions

Students with honors in the 2023-24 academic year in subjects taken at Euncet have an exemption from the 2024-25 tuition fee of 25% of the amount of the number of credits obtained with this academic qualification. It is cumulative.

• For example, a student who has obtained 12 subject credits with honors in the 2023-24 academic year will have a discount of:

12 credits x credit price 1st time 2024-25 academic year x 25 % = discount

2.4 Family aids

14% to be deducted from the total tuition fee for the 2024-2025 course. It is not cumulative.

- Student with one or more siblings enrolled in the same academic year of a Euncet university degree or master's degree.
- Student with a valid large or single-parent family card.
- Student with a family income of less than €30,000 gross per year (family unit).

2.5 **Professional aids**

9% to be deducted from the total tuition fee for the 2024-2025 course. It is not cumulative.

- Student who certifies more than one year as a self-employed worker.
- Student who is legally unemployed.

2.6 UFEC aids

9% to be deducted from the total tuition fee for the 2024-2025 course. It is not cumulative.

• Student with a membership card from one of the Catalan, Spanish or international sports federations and with a minimum seniority of 3 years.

2.7 Educational Institution aids

18% to be deducted from the total tuition fee for the 2024-2025 course. It is not cumulative.

• A student who has completed the baccalaureate or a training cycle in a training center that has a collaboration agreement signed with Euncet. It is only applicable to the registration of the 1st year.

2.8 Aids to EUROFITNESS, LEITAT and UFEC employees

18% to be deducted from the total tuition fee for the 2024-2025 course. It is not cumulative.

• Student with an employment contract at one of these institutions at the time of registration.

In certain cases, the commercial department may grant financial **aid not explicitly contemplated** in this document.

It is necessary to bear in mind that these scholarships and aids cannot be accumulated in any case. They are only compatible with the **5% discount for choosing a single payment as the tuition payment method**.

3 Admission

Admission will be carried out through the digital platform (e-Euncet) to which the interested person will be referred once he/she requests access to the Degree. To formalize admission to a degree, the interested person must make a payment of 600 euros as a registration deposit. In this process, the candidate will be able to choose the class schedule in the case of being admitted through university pre-registration. The study modality (On-Site/On-Site Part-Time) will be assigned by university pre-registration. No refund, neither total nor partial, of this amount will be made, except in the event that the candidate does not meet the access requirements. Once registration is formalized, the amount advanced for admission will be deducted.

This payment does not guarantee in any case access to the requested university degree. To access the degree, it is necessary to meet the requirements established by the university access office of the Generalitat de Catalunya (Accesnet).

4 Payment methods

4.1 Single payment

This payment option has an **additional 5% discount** on the amount of enrolled credits less scholarships, grants and reserves, as long as payment is made within **5 business days at the latest after formalizing registration**. Payment must be made through the e-Euncet digital platform. The bank transfer must be in **Euro currency**. Any bank transaction costs will be borne by the payer.

4.2 Payment in instalments

This payment option has the following features:

- It may be divided into a maximum of 10 installments (the minimum being 2 and the maximum being 10), although the last one to be paid, regardless of the month in which the first one began to be paid, cannot be later than June 5, 2025.
- **<u>As a general rule</u>**, all installments will be the same amount.
- Receipts are issued on the 5th of each month from the date of registration and can be deposited into any financial institution.
- This modality has no interest or commissions.
- In case of return of the direct debit receipt, a surcharge of **30 euros will be charged** for management actions.

5 Consequences of not paying tuition

Failure to pay the tuition or some of the installments within the established deadlines may result in the temporary suspension of the student's rights in the terms provided in the decree



that sets the prices for the provision of academic services in Catalan public universities of the current academic year.

Payment of unpaid instalments of previous courses is required as a prior condition for enrollment or the issuance of degrees or certificates.

6 Enrollment modifications

The Euncet academic calendar provides, for each school period, a deadline to accept requests for modification of registration:

- First quarter:
 - **From September 2 to 27, 2024:** registration modification requests are accepted. Those that are resolved favorably have no cost to the student.
 - **From September 28, 2024, on,** registration modification requests will **NOT** be accepted.
- Second quarter:
 - **From January 7 to February 7, 2025**: registration modification requests are accepted. Those that are resolved favorably have no cost to the student.
 - **From February 8, 2025, on**, registration modification requests will **NOT** be accepted.

In the second quarter, **a subject can only be eliminated from registration if it is replaced by another**. It is allowed to **add subjects** to the registration and request **group changes**.

7 Tuition resignation

As a general rule, **registration cannot be waived**. However, in duly justified cases and only once, students may request a total waiver of enrollment and to receive the requested academic services as long as they do so within the period established in the academic calendar, regardless of the date on which registration has been formalized.

In any case, students who renounce registration for the first year will lose their assigned place and, if they wish to re-enroll, they must be admitted again in the pre-registration process or in accordance with the access regulations of those studies.

Euncet's academic calendar has a deadline to accept applications for waiver of registration:

- **Until September 27, 2024**: all requests to waive registration will be evaluated favorably and the entire amount that the student has paid will be returned, except for the admission reservation for new access candidates.
- From September 28 to October 19, 2024: all requests to waive registration will be evaluated favorably, but the student must pay a fee of 1,000 euros.
- From October 20, 2024, on, applications to waive registration will NOT be accepted.

The **access fee to the content is 80 euros** per subject enrolled at the time of resignation.

- Official university degree and master's degree with European Supplement on the Title (and duplicates): 218,15 euros
- Issuance of official academic certifications: 27,27 euros
- Issuance of academic certificates: 30 euros
- Transfer of academic record: 54,54 euros
- Academic record studies for validation, adaptation, transfer and recognition of study plans: 54,54 euros
