## 1 Prices

---

### 1.1 Price per credit in Executive Education

- Price per credit of the On-Site Global Executive Master in Business Administration (MBA): **165 euros/credit**.
- Price per credit of the On-Site Executive Postgraduates: **173,33 euros/credit**.
- Price per credit of the Online Global Executive Master in Business Administration (MBA) Online: **100 euros/credit**.
- Price per credit of the Online Executive Postgraduates: **100 euros/credit**.

## 2 Scholarships

---

Below are the different scholarships offered by Euncet Business School for its Executive Education programs. It should be noted that **none of these scholarships are applicable to Executive Education programs in online modality**.

### 2.1 Euncet Alumni Scholarship

The Euncet Alumni Scholarship is aimed at those students from the Euncet community who are in the last year of the course or have completed one of the degrees taught by Euncet Business School and want to study one of the master's or postgraduate degrees of Executive Education training.

These financial aids are in the form of a discount on the total amount of tuition for the 2024-2025 course. It must be taken into account that these scholarships are by no means cumulative and are only compatible with the **5% discount for making a single payment** at the time of registration.

- **On-Site Global Executive Master in Business Administration (MBA): 25 % discount.**
- **On-Site Executive Postgraduates: 25 % discount.**

#### Access requirements

- Prove that you have taken or are taking the last year of any of the degrees taught by Euncet Business School.

### 2.2 UPC Alumni Scholarship

As a centre attached to the Universitat Politècnica de Catalunya (UPC), the UPC Alumni Scholarship is aimed at those students who have completed any degree at the UPC and want to expand their training with one of the Executive Education programs at Euncet Business School.

These financial aids are in the form of a discount on the total amount of tuition for the 2024-2025 course. It must be taken into account that these scholarships are by no means cumulative and are only compatible with the **5% discount for making a single payment** at the time of registration.

- On-Site Global Executive Master in Business Administration (MBA): 20 % discount.
- On-Site Executive Postgraduates: 20 % discount.

## 2.3 Self-Employed / Unemployed Scholarship

At Euncet Business School we want to facilitate access to our executive training programs so that any professional can achieve his/her goals. For this reason, the Self-Employed Scholarship is aimed at all those self-employed professionals who want to reinvent themselves and see our Executive Education program as an opportunity to face the new business challenges that arise.

These financial aids are in the form of a discount on the total amount of tuition for the 2024-2025 course. It must be taken into account that these scholarships are by no means cumulative and are only compatible with the **5% discount for making a single payment** at the time of registration.

- On-Site Global Executive Master in Business Administration (MBA): 20 % discount.
- On-Site Executive Postgraduates: 20 % discount.

### Access requirements

- Prove that you are registered as self-employed or are legally unemployed.

## 2.4 Business Scholarship

The Business Scholarship is intended for those organizations that have a collaboration agreement and that want to bet on one of the most precious assets for any business: internal talent. Our executive training aims to train professionals who are capable of leading the challenges of tomorrow. At Euncet Business School we have always had a close link with the different business sectors. As a result of the uncertain panorama in which we live, we wanted to launch this financial aid to facilitate and promote the professional growth of internal talent in companies.

These financial aids are in the form of a discount on the total amount of tuition for the 2024-2025 course. It must be taken into account that these scholarships are by no means cumulative and are only compatible with the **5% discount for making a single payment** at the time of registration.

- On-Site Global Executive Master in Business Administration (MBA): 25 % discount.
- On-Site Executive Postgraduates: 25 % discount.

### Access requirements

- Include a motivation letter that highlights skills, aptitudes and professional merits.

## 3 Special prices for online Executive Education

---

Future students of an online Executive Education program will enjoy a **special price if they register before July 29, 2024** through a **single payment**:

- Online Global Executive Master in Business Administration (MBA): **1.500 euros**.
- Online Executive Postgraduate: **1.200 euros**.

## 4 Admission

---

All those interested in starting an Executive Education program can apply for admission throughout the year, but, depending on the program and the number of places available, they may be admitted in the first or second semester of the academic year.

Therefore, two specific admission calls are established:

### First call: first semester

The admission period to start Executive Education programs in October - November of the current year begins in January and ends in October.

### Second call: second semester

The admission period to start Executive Education programs in March – April of the current year begins in October and ends in March.

## 5 Payment methods

---

### 5.1 Single payment of the On-Site Executive Education programs

The **5% discount** for early payment will be applied to the remaining amount once the program place reservation has been made as long as the payment is made at the latest **within 5 business days after formalizing the registration**.

## 5.2 Payment in instalments of the On-Site Executive Education programs

At Euncet Business School we offer you tailored financing solutions, without interest or commissions, so you can choose the option that best suits your situation. You can decide in how many instalments you will make the payment and when you will start making it, as long as the full amount is paid before the program ends.

\*These conditions do not apply to online Executive Education programs.

## 6 Consequences of not paying tuition

---

Failure to pay the tuition or some of the instalments within the established deadlines may result in the temporary suspension of the student's rights in the terms provided in the decree that sets the prices for the provision of academic services in Catalan public universities of the current academic year.

Payment of unpaid instalments of previous academic years is required as a prior condition for enrolment or the issuance of degrees or certificates.

## 7 Waiver of registration

---

As a general rule, **registration cannot be waived**, although in justified cases and for a single time, students can request a total waiver of registration and the academic services requested as long as it is not done within the period established in the academic calendar. The student will have to submit the request alleging the reasons for waiving enrolment.

The director of the EME programs will resolve the resignation request submitted. Regarding the student's record, Euncet Business School may proceed to academically withdraw from the program.
